SYNOPSIS									
On Mon 31 Oct 11 at 0301 hours, P/O's Elliott #2131, Wells #2119, and Melton #2134 were dispatched to 4403 Douglas St. While enroute, P/O's received an update that the suspect BLACK, Joseph (3-17-79) was having a psychotic episode. Upon arrival, Black was assaulting his mother. Black put the vehicle in reverse, rammed a police cruiser and sped off from the scene. The owner of the vehicle, DARGENTMAN, Laura (7-13-81) stated she gave Black the keys out of fear. Black was apprehended and taken into custody a short time later. Sgt OTT #1479 and Lt. SEPLAKER #1191 were on scene.
