Reporting Sergeant BAKER, D.L. #1113 observed above vehicle #1 W/B on 108th from Mockingbird At 2120 hours, Sunday, 18 April 99, vehicle #1 had a burned out passengers' side low beam headlight and had the high-beam headlights on glazing into oncoming (SIB) traffic. As vehicle #1 passed R/S, R/S noted the hood & side were covered with mud. R/S turned to follow and stopped vehicle #1 at 11700 L st W/B where I was assisted by Officer R VLCEK #1207. The driver provided a DL & State ID identifying himself as BLACK, Joseph. Black had an insurance card indicating the vehicle was insured until MAY 99, but channel 5 indicated that BLACK had been cancelled, and suspended for that cancellation on 3-10-99. This was the third time since April, 99 that BLACK has been stopped & cited for driving during suspension, including once previously by officer VLCEK. Vehicle #1 was impounded. BLACK was cited for PWS, Fail to Dim & No financial Responsibility.
