SYNOPSIS

On TUE 11SEP01 at 1307 hrs. RO FREER, #1279 observed above listed vehicle turn onto Tangier Way without regard to an oncoming vehicle - which I was following. A Blk 97 Pontiac FV631 appeared to be chasing the FORD and he pulled out in front of RO. RO activated lights near 844 Tangier Way and both vehicles pulled over. Driver of above listed vehicle stated the other driver was "stalking" him. RO called for BACK-UP and Ran both drivers on channel 5. Suspect one, BLACK, had 4 warrants, he was placed into custody and OFC TANNER #1214 searched/inventoried the vehicle prior to tow. (Vehicle had no plates and was purchased on 4-01) Second driver, JACKSON, Harold 4-6-80, was cited and released. RO transported BLACK to central, where he was booked on 4 warrants, CCW-Knife and No Valid Registration. OFC. Tanner located the knife tucked on the right side of the drivers seat
